THE COINAGE OF INDIA

SANDEEP SHAH

fter Queen Victoria died in 1901, her elder son, Kind Edward VII ascended the throne. The Edward VII series of coins of India are dated 1903 - 1910. There are four silver coins (Rupee, 1/2 Rupee, 1/4 Rupee and 2 Annas) and three copper coins (1/4 Anna, 1/2 Pice and 1/12 Anna). A cupro-nickel 1 Anna coin was introduced in 1906. That same year the copper coins were replaced by bronze issues with the same obverse and reverse designs but with thinner plancet. The 1906 coins come in both varieties of copper and bronze issues. The King Edward VII coins are distinct as the head is uncrowned. The apparent explanation

is, that when
Queen Victoria
died on 22nd
January 1901,
Edward's
coronation was
not held till 9th
August 1902. The
master dies were
created before
the coronation, so

it was not possible to show him wearing the crown! On 5th December 1902, it was announced that from 1st January 1903 the new coins will be issued. It is reported that a new portrait was prepared in 1910, but King Edward died the same year. The



one Anna coin was introduced in 1906 and it does have a portrait of a King wearing the crown.





UNDERSTANDING SHRI RAM RAKSHA STOTRA

i friends, I am Krupa Shah and welcome back to next episode of reviving the ride to mysterious world. Let's open the untouched walls of this world but firstly, let me congratulate everybody on grand opening of Ram mandir in Ayodhya. With lighting of divas at the doorsteps on this auspicious occasion and hearts full of positivity, let us talk about in detail about 'Ram Raksha Stotra'.

Sri Ram Raksha Stotra is most powerful protective shield. It was originally composed in the Sanskrit language and is one of the most popular Hindu devotional prayers that is address to Lord Shri Ramchandra. Shiv Bhagwan ordered sage Buddha Kaushika to create the most powerful protective shield for devotes and sage Buddha Kaushika under the advice of Shivji wrote Shri Ram Raksha Stotra. There is reference to this divine hymen in Rig Veda. Ram Raksha literally means protection from lord Shri Rama to us. It is Shri Ram's armour called Vajrapanjarnamedan. Ram Raksha Stotra along with shri Hanuman chalisa are considered as the most powerful protective shields in the form of mantra. It is said that a devotee is always protected and nothing effects to devotee.

PUBLIC BUDGET AND DEFICIT BUDGET

inance Minister has recently presented Union budget. Implications of the budget will be seen in coming months. But lets try to understand the meaning of public budget, types of budget and mainly what's deficit budget. This is basic economics but for a common man, what does it mean? Lets go little academic today. The government budget is an important tool for the implementation of its policy decisions. But the ultimate purpose should be to achieve social, economic and political objectives. Budget should serve as a tool for economic and financial management. But the accountability is attached wth it. Its not good to pass on the blame to others on failures. We know that all political parties use the budget as an important instrument to further their objectives. But the primary objective of any government should be 'Welfare of the people'.

Let us understand different types of budget, in simple language.

- 1) Balanced and Unbalanced budget: When revenues are equal to expenditure it is called balanced budget. This is possible only in theories. When the revenues and expenditures are not equal it is called unbalanced budget. When the revenues are greater we have surplus budget and when expenditure is more than revenue, we have deficit budget.
- 2) Zero based budget and traditional budget: When every item of budget is to be approved, all expenses needed to be justified for each New year www.khadayatabusinessnetwork.com

then it is called Zero based budget. Whereas in the traditional budget changes over the past years are to be justified. The programs and projects of the previous years are automatically continued and funded in the coming years.

- 3) Performance and program budget: When the end results of a program or activity are taken into account to ensure cost effectiveness and efficient planning, it is called Performance budget. Whereas in Program budget, the major function of the government is divided into specific programs, activities and projects. Then the funds are allocated according to the achievements expected from each of the program over specific period. 4) Legislative and executive budget: When the budget is prepared by law making bodylegislature directly or with the help of committees it is called Legislative budget. The Executive budget is prepared by executive wing of the government and it is responsible for the implementation of the budget proposals prepared by the legislature.
- 5) Revenue budget and capital budget: All those items which are recurring in nature are covered in Revenue budget. This budget shows both revenue receipts and revenue expenditure. Revenue receipts consists of tax revenue and non-tax revenue. (i) Revenue from direct taxes and (ii) Revenue from indirect taxes are components of tax revenue.

Non-tax revenue consists of interest and dividend, fees and other receipts for services rendered by

the government. Revenue expenditure is expenditure on maintaining existing level of public services. This expenditure should ideally be met through revenue receipts and not through borrowings.

Capital budget consists of capital receipts and capital expenditure funds received by the government in the form of market borrowings, small savings, provident fund, recovery of loans, disinvestment receipts and other receipts from sale of government assets. Capital expenditures include repayment of debts and all expenditure on infrastructure like roads, railroads, irrigation and power generation projects, establishment of schools, health-care infrastructure etc.

Now let us try to understand the concept of Deficit Budget. When the government expenditure exceeds revenues the government has a deficit in budget. The government finances this mainly by borrowing from the public through selling bonds. This gives rise to public debt. The deficit may also be financed by borrowings from the central bank of country i.e. Reserve Bank of India. That causes the aggregate demand in the economy to rise and ultimately lead to inflation. So borrowings from RBI is dangerous. Now you can understand, why two RBI governors have resigned and did not support government policy. This is going to be inflationary in coming years. Lets hope for the best !

LEARNING DISORDER IN CHILDREN; ADHD ETC.

hen we were kids parents were aware about our studies but in case if a child could not cope up he would be labelled as a duffer and the matter would end at that.

Thanks to 'Tare zameen par', now people are more aware of the problem.

Let us understand what are the different kinds of learning difficulties.

- 1. Difficulty in paying attention. There are 2 variations to the problem. Attention difficulty with restless personality is termed as ADHD(Attention deficit hyperactivity disorder). Attention difficulty in an otherwise normal looking child is termed as ADD (Attention deficit disorder).
- 2. Difficulty in writing / holding pen etc. motor skills in such a child are not developed properly.
 3. Difficulty in perception- in such cases the child has difficulty in recognising similar looking letterseg.they may get confused between letters like b and d; in Indian language between t and d etc. Such children also tend to reverse the order of writing things and hence poor at MATHS.
- 4. Very often difficulty in reading a board is not recognised. He / she may have myopia. Simple glasses resolve the issue.

I have seen that secondary to the learning issue sometimes the entire family gets disturbed and is a cause for marital discord. The blame game starts and instead of trying to solve the child's problem it becomes a reason for quarrel. It also is seen as social stigma. It is really sad but true.

It is my sincere appeal to such parents to wake up to their child's needs.

In the past few years since there is more awareness the problems have reduced. Schools are taking initiative to recognise such children and give them right guidance and help as much as possible.

Diagnosis

Special tests are available in order to detect the exact nature of the problem and solve it.

The team of people that help these children are

• Special Educator

- Child psychologist
- Speech therapist
- Occupation therapist
- Ophthalmologist
- ENT specialist
- School
- Medication

Nowadays many schools are receptive about the difficulties of children and they help the process of diagnosis as well as its further course of action. Yet, everything can not be put on the school. If the parents are alert the problem can be resolved

early. It is not needed to label a child. Simply helping him in the area that he lacks is much more important. A lot of parents do not know whom to talk to in such a case.

Treatment

The treatment can be divided into 2 parts. One is therapy and the other is medication.

Therapy

Depending on the type of problem the therapy is decided.

- learning of the child. They are trained to simplify the learning and make it easier for children. Of course they are generally licensed to conduct tests and diagnose a specific problem related to learning. They also help in specific areas of reading, letter reversal, maths etc.
- Child psychologist children are very delicate. They sometimes do not open up so fast. We tend to ignore children thinking what problems they can have! Fact is when they are learning new things they may find many things intimidating. A skilled professional becomes very helpful in understanding the difficulties as well as helping them cope up.
- ENT SPECIALIST generally diagnoses the problem and Speech Therapist comes into picture if the problem is related to speech
- If the problem is related to reading difficulty, the first thing to do is to consult an Ophthalmologist to rule out vision impairment. If there is a problem the child will need to wear glasses.
- If the problem is in the area of writing then Occupation Therapists are able help these children. They give them exercises related to small muscles of hand in order to develop better grip over the pen and more coordination of muscles required for writing.

ADHD

Attention deficit hyperactivity disorder is one problem that actually concerns the parents the most. Such a child is very difficult to manage. Sometimes these children have destructive tendencies. They find it very difficult to focus on one thing and hence they tend to mess around.

It is commonly observed that a hyperactive child tends to eat a lot of sugar or surgery substance. The brain goes into a sort of hyperdrive when it gets a large dose of sugar at a time. That is the time they can be extremely restless. Since that sugar is used up fast they feel drained out equally fast so they tend to rely on sugar for their source of energy. Hence **stopping sugar** in all forms is very important. It may not be as easy as it sounds as for them it becomes like an addiction.

Role of HOMOEOPATHY

Actually HOMEOPATHY has a very big role to play in such conditions. We in fact we get a lot of cases. In mainstream medicine they give medicine that slows down the mental waves so that the child is able to focus in his school. But the medicine works temporarily. Plus it has its side effects so they recommend stoppage of medicine during vacation times. The actual problem faced by the child does not get solved at all.


